## Purpose

- The Coordinated Enrollment Pilot Expansion will ensure each child and their family can access:
- Quality Early Child Care Education (ECCE) services; and
- Essential services to support each child's healthy development.



# **Expanding What Works**

- NECC currently provides limited coordinated enrollment services to the three Omaha Early Learning Centers at Gateway, Kennedy, and Skinner as part of an EHS-CCP grant.
- What happens to those families who are over-income for Early Head Start or are on a waitlist?
- The Coordinated Enrollment Pilot Expansion will allow those families to receive the support necessary to enroll in quality ECCE service.



## Services to Families

- One point of access for families to:
  - Receive information and education about quality childcare;
  - Screen for eligibility and apply for public benefits;
  - Receive relevant community referrals to eliminate barriers; and
  - Complete enrollment paperwork as necessary for the participating childcare program of their choice.
- Families will be served by one Coordinated Enrollment Specialist throughout the process.

- Business Training Series
  - 10-week, 30-hour training that covers family child care business topics such as; marketing, contracts, policies/parent handbooks, budgeting, taxes, risk management, more
  - Inservice hours/stipend to attend
- Business Consultation/The Learning Community
  - Optional 8-week, extension of the BTS, facilitated utilizing the Business Administration Scale (BAS) and harnesses peer learning supports
- Licensing Toolkit
  - Inspired by the work of AOK, the Licensing Toolkit is a customized program specifically designed for Nebraska Family Child Care Licensure


